## DEMOCRATIC CONVENTION. CABARRUS DEMOCRATS SOLID

For Klutz for Congress, Platt D. Walker for Associate Justice, J. Y. Joyner for Superintendent of Public Instruction and Webb for Solicitor—For Justice 49.16, Clark 21.84, Conner 42.4, Brown 28.6, Beddingfield 48.5, T. W. Mason 22.5—Elect U. S. Senators by the Good Old Way.

The Democratic Congressional, State and Judicial Convention for Cabarrus met in the court house at 1 p. m. Saturday, the 21st. Chairman Young called the meeting to order and requested Messrs. J. B. Sherrill, J. F. Hurley and J. D. Barrier to act as secretaries.

It was found that townships Nos. 3 and 7 were not represented. Chairman Young then called Mr. D. Henry White to the chair and the organization was made permanent.

The following preamble and resolutions were read, viz:

Whereas, At a meeting of the Democratic Executive Committee for Cabarrus county, in Concord, N. C., May 31st, 1902, the following preamble and resolutions were unanimously adopted:

"Whereas, The last General Assembly of North Carolina enacted a law whereby Mecklenburg and Cabarrus counties jointly shall elect two senators, and whereas, it is desirable and necessary for the Democratic party's success, as to the election of said senators, that there be an amicable and just understanding between the organizations of the Democratic party of the two counties on the question of nominating these two senators; now, therefore, by the Democratic Executive Committee of Cabarrus county, in session in Concord, this day, May 31st, 1902, be it unanimously

Resolved, That W. G. Means, Jonas Cook and A. B. Young are hereby appointed and constituted commissioners from this committee to confer and consult, on Wednesday, June 4th, 1902, in Charlotte, with the Democratic Executive Committee of Mecklenburg county, or such commissioners as said last named committee may elect, on the nomination and election of said two senators and on all questions properly incidental thereto and, with said committee or commissioners for Mecklenburg county, to fully settle these questions as far as the same can be settled outside of county primaries and conventions for Mecklenburg and Cabarrus. We, the Executive Committee of Cabarrus pledging ourselves that the joint action of our commissioners and those acting for Mecklenburg county shall be binding on the party we represent as far as we can make them so, and to this end the commissioners from Cabarrus are granted all the power that this committee can confer.

"Resolved 2. That Mr. A. B. Young, chairman of this committee, is hereby requested and authorized to immediately inform Mr. J. D. McCall, the chairman of the Democratic Executive Committee of Mecklenburg county, of this action and send him a copy of these resolutions; and

"Whereas, Mr. A. B. Young, chairman, did, in accordance with said second resolution, notify Mr. J. D. McCall, chairman; and said commissioners for the Democratic party of Cabarrus county, did, on the 4th day of June, 1902, meet with the Democratic Central Committee of Mecklenburg county, in Charlotte, N. C., and did, as the duly authorized agents of the Democratic party of said counties, adopt the following:

"We, the undersigned commissioners on the part of the Democratic Executive Committee of Cabarrus county, and the Democratic Central Committee of Mecklenburg county, hereby suggest the following arrangement in regard to selecting the two State Senators allotted to this district:

"First. That the Democrats of Cabarrus county shall select one candidate for the State Senate by any method they may deem best.

"Second. That the Democrats of Mecklenburg county shall select the other candidate for the State Senate by any method they may deem best.

"Third. We recommend that the Democratic county conventions of Mecklenburg and Cabarrus counties ratify this action.

"Now, therefore, the Democratic party of Cabarrus county in convention assembled, in Concord, this the 21st day of June, 1902, does hereby unanimously ratify and confirm the foregoing action of said commissioners for Cabarrus county and the Democratic Central Committee for Mecklenburg county, but it is expressly declared that said action and this ratification and confirmation thereof should not have the force and effect of a precedent in future campaigns if the Democratic Executive Committees of said counties shall jointly prescribe a different way of nominating the senators to which said counties are entitled."

The resolutions were unanimously adopted.

Col. P. B. Means then read a request from the State Democratic Executive Committee asking an expression from each county as to the method of choosing United States Senators.

On a motion to elect by the legislature in the old way there were 58 yeas and 13 nays.

The vote by townships and wards was then taken to instruct the delegates to the different counties and resulted as follows:

## BLOODY FIGHT IN KNOXVILLE.

Philippine Soldiers' Resent Truancy—One Man Dead and Three May Die.

Knoxville, June 22.—An attack upon the army in the Philippines made at a garden party here, last night, started a desperate fight which may cost four lives. One man is dead and three others, including the trader of the soldiers and a discharged regular, recently returned from Manila, who defended the name of the military, are probably fatally wounded.

John Kennedy, aged 45, was killed. The injured are: Alonzo Barger, stabbed twenty times, cannot recover; Charles Hobbs, badly cut about the face, neck and breast, Lincoln Monday, stabbed, jugular vein almost severed.

Monday, who served three years in the archipelago, as a member of the Ninth Infantry and who is a survivor of the massacres of Company M, at Balangiga, Samar, gave Barger the lie when the latter declared that "two-thirds of the American soldiers who went to the Philippines were hoodlums and the other third were cowards and bullies."

In the fight that followed, Hobbs and Kennedy took the part of Barger. All fought with pocket knives until Monday, weak from loss of blood, sank to the ground. Then one of his friends in the crowd handed him a revolver and he shot Kennedy dead. Monday then shot at Barger and Hobbs, but failed to hit either.
