CITY PRACTICALLY UNDER THE RULE
OF THE MILITARY.

Leader of Mob Held—Francis J. Cross, a Well Known Salisburian, Arrested on the Charge of Committing Without Bond—Grim Gating Gums Still Threaten and Troops Parade Constantly—Strong Sentiment in Favor of the Mob.

It has been reported to us by Mr. W. O. Odell, our press representative, that he will not accept a commission from his reelection if forced to do so.
