school houses having shingle roofs. While the ordinance' is not retroactive, all premium payments on fire insurance policies made after November 3, 1927, will receive the benefits of the new rate. This is important in that not only the holders of new policies will be benefitted but also those people who have paid the old rate for many years.

The gist of the Anti-Wood-Shingle-Roof ordinance is found in Sections 4 and 6. The first named division decrees that if a wood-shingle-roof is damaged twenty per cent of its committee in charge of the program value by fire, the entire roof must be replaced by coverings which comply with the ordinance. Also, if a shingle roof must be renaired more than ten per cent, the whole roof must be covered in compliance with the ordinance

Section 6 provides that within 15 years from the date of the approval of the ordinance that any and all roofs covered with wood shingles Section Were Included in shall be replaced with roof coverings the Christmas Rush at which comply with the ordinance.






