ALLENS CALL IN FACE OF DAMNING EVIDENCE

Editor Johnson Gives Some First Hand News from Trial of Outlaws. Editor J. E. Johnson, of the Mt. Airy News, has just returned from Wytheville, Virginia, where had been to get some news first-hand from the Allen trial now in progress. He said that there were a dozen or more newspaper men on the job, and that the trial was progressing nicely with no evidences of excitement. He also said that sentiment in that locality was very much against the Allens, and that capital punishment for those of the gang now on trial would not surprise him in the least. He said that the men now on trial, and especially Floyd Allen, seemed very calm and confident, notwithstanding the damning evidence being submitted against them.
