#### PRES. COOLIDGE IS CANDIDATE

Has Entered His Name In the Ohio Presidentil Preference Primary By Filing His Dec-

Columbus, O., Feb. 23.-President Coolidge formally entered today the Ohio Republican presidential preference primaries for president by filing his declaration with Secretary of State Brown.

Simultaneous with Mr. Coolidge's filing Arthur L. Garford, Elryia, Ohio, also filed with the secretary of state in an authorization for the use of his name as second choice candidate in compliance with the Ohio primary

Wilson, Feb. 23 .- Official reports, furnished by H. B. Johnson, supervisor of sales on the Wilson market, shows that up the closing sales Thursday this morket had sold 70,797,250 pounds of tobacco for \$15,797,-482.84—an avarage of \$22.22 per hundred pounds. #### STATE'S SURVEY IS ENDORSED

Passes Resolution At Meeting Here Tuesday-Other Business Transacted.

At a meeting of the Stokes County Highway Commission held here Tuesday of this week a resolution was passed by the Board endorsing the survey as made by the State Highway Commission for the proposed hard-surface road from the Forsyth county line to Danbury, and the State was urged to award contract for the construction of this road as early as possible.

An order was made by the Board that survey be made of the Piedmont-Moore's Springs road at once and that work be started on this road immediately or as soon as the forces can be put on it.

The proposed road from Danbury to Flat Shoal church was ordered surveyed as soon as

The bridge to be erected over Snow Creek in Snow Creek township, the re-location of which has been under consideration, was ordered built at the original site, and the road leading to it was ordered to be constructed by way of the short or lower route.

The road leading from John Morefield's west to the highway Lawsonville was ordered built as soon as possible.

Commissioner E. R. Nelson was appointed a committee to see that a road near R. M. Smith's, which has been obstructed recently, is opened up to travel.

County Engineer N. S. Mulli. can was again employed by the Board on a per diem basis.

All members of the Board were present at Tuesday's meeting. The Board will meet again next Monday.

#### New Member Board Not Named Yet

Spencer on the first Monday in February, has not yet been filled, and it is stated that there are no applicants for the position. The office is apparently not a very desirable one.
