STOKES BOARD OF ELECTIONS MEETS AND SETS UP MACHINERY FOR ELECTION OF NOVEMBER 7 ON THE QUESTION OF REPEAL.

To the voters of Stokes County: At a meeting of the Board of Elections held at Danbury Sunday, September 9, for the purpose of designating registrars and judges for the coming election on November 7...

The law requires that we appoint one judge in each precinct who favors repeal of the 18th Amendment and one who opposes repeal. Not being fully informed as to the attitude of the various voters in all of the precincts we determined to ask that the "Dry Organization" in the county, through its proper officers, forward to us a list of 10 qualified voters in each precinct...

We are assuming this attitude and making this suggestion in order that each organization may have fair and equal representation at each polling place.


