SCOTT RALLY COMING JUNE 25

COUNTY HOME AND STATE HIGHWAY GROUPS STAGING FISH FRY AND GET-TOGETHER CONFAB FOR SATURDAY NIGHT JUNE 25--TO ORGANIZE PRECINCTS FOR STOKES MAN FOR SOLICITOR.

The Stokes Democratic organization will meet in conference with Scott friends from Rockingham, Caswell and Surry Saturday night, June 25, for the purpose of assembling the Scott vote in four counties for action on primary day, July 2.

The place of meeting is the cool, sequestered picnic ground adjacent to the county convict camp and the county home. STOKES FARMERS RECEIVE CHECKS

MORE THAN \$32,000 HAS COME SO FAR TO FOUR TOWNSHIPS—OTHERS EXPECTED SOON—B. H. JESSUP PUTS IN MODERN WATER SUPPLY.

To date, we have received 778 checks amounting to \$32,370.28. Most of these checks were for Big Creek, Peters Creek, Beaver Island and Meadows townships. When checks are received, notices are mailed immediately to every producer who has a check at the county office. We are endeavoring to make it as convenient as possible for producers to get their checks and when checks arrive they are being taken by the treasurer to central points in the various townships. This will save many farmers the time and trouble of coming to the county office to sign for their checks. Farmers are requested not to call at the office for their checks until they have received notice that it has arrived. We hope to receive the remainder of the checks for all the townships in the County at an early date.

HYDRAULIC RAM

B. H. Jessup, of Lawsonville, walked 12,000 miles, almost half way around the world and spent more than 2 1/2 years over a period of 30 years carrying water from the spring to the house before he installed a hydraulic ram on his farm a few days ago and saved this unnecessary drudgery. For a total cost of \$131.00, Mr. Jessup installed a hydraulic ram that is delivering 27 gallons of pure, clean, cold spring water to his house every hour, or 648 gallons every 24 hours. This cost included the ram, pipe, concrete or everything that was used in the installation.

This ram is pumping water to an elevation of 30 feet and delivering the water from a spring 700 feet from the house. In regarding about his new water system, Mr. Jessup stated that he just didn't understand how he did without running water at his house for so long a time. He plans to make a complete installation by installing a kitchen sink and a bath room and pipe the spring water to the barn.
