This was made clear to local selective service officals yesterday by General J. Van B. Metts. state director of selective service. as he announced a modification of the former policy of leniency toward married men which has been recommended by state headquarters. General Metts stated that a modifacation in this policy

was made necessary by an increasingly large number of registrants who are apparently undertaking to abuse the policy of leniency in an effort to evade military service.
