



are being made at the Treasury Department for an immediate bond issue. Secretary Carlisle will await a reasonable time for Congress to act, probably until February 1st, before he proceeds independently of Congress, on the presumption that, now as he has officially called the attention of Congress to the urgent needs

Until Congress shows that it will not relieve the treasury, the Secretary will not feel called upon, on his own responsibility, to issue bonds under the resumption act.
