Courts Cannot Cure Vital Defects in Acts of the Legislature-Two Justices Dissent. (Special to The Messenger.)

ILLEGAL TAXATION.

Raleigh, N. C., April 23 .- A decision of the supreme court filed this evening puts in effect the poll tax and and to choose the state board of ex- general tax of 1895. It was rendered in

The majority of the court decide that sections 2 and 3 of the revenue act are unconstitutional and void, leaving the corresponding act of 1895 in force. Justices Clark and Douglass dissent.

The opinion is lengthy and is written by Justice Montgomery. It overrules the decision of Judge Adams and sustains the demurrer of Auditor Ayer. Agricultural Department Officials Inspect

Raleigh, N. C., April 23. Superintendent Smith of the penitenlary today went to the penitentiary farm at Castle Haynes, to arrange for sending more convicts there.

There is a queer state of affairs in egard to the bookkeeper at the penitntiary. Frank Wimbish, of Oxford, was elected.
