Doted with Powder, Shot and Other Mysterious Mixtures Made at Midnight.

LITTLE ROCK, Ark., Aug. 15.-An extraordinary illustration of human credulity has been developed in the trial at Arkansas City, Ark., of Dr. Henry Harris, charged with the murder of James Venters, a colored man who had accumulated considerable property. Harris is known as a "voudoo doctor." He has an extensive practice in the swamps of Southern Arkansas and Mississippi, where the negroes regard him as a magican of good or evil. He gathers herbs and roots at midnight, the darkies say, and his knowledge of voudooism is unlimited. He attended Venters at the first stage of his illness, A white physician was called, as the sick man grew worse who said he was suffering from poi-

If appears Venters had taken a dose of powder and shot, besides other mixtures of a mysterious nature. When he died Harris was put on trial for murder. The evidence showed a limitless range of ignorance and duplicity. Nearly all the witnesses expressed a firm belief in Voudooism. Marvelous experiences were told. The disciple of the voudoo practice was shown to hold life and death in the hollow of his hand. Numbers of cases where Harris had saved life and exorcised evil spirits from white and black, young and old, were cited. The instruments appeared to be faith,

charms and incantations. The jury, however, found Harris guilty of manslaughter, fixing his punishment at eight months, imprisonment. There is much dissatisfaction. His triends say his conviction is an outrage, a travesty of justice. There are others who hold a different opinion, and it is said to night that he may yet sufler death at the hands of his victim's.

CHATS WORTH.

Two Men Arrested as the In cendiaries Who Caused The Wreck.

CHICAGO, August 15.—The Times to-day has a dispatch stating that two men have been arrested on the charge of being the incendiaries who caused the Chatsworth horror. The authority given for the information is a man named L. Dobbs, who has been working for some time past for a farmer named Morris Kenoya, about three miles from Kentland, Ind. Dobbs informed the Times correspondent that the two men were arrested on suspicion of having set the bridge on fire. They were given a preliminary examination before a justice of the peace, and the proof against them was considered strong enough to hold them in jail. where they are now confined pending further proceedings. Dobbs added that his employer Kenoya was present at the examination. The correspondent interviewed W. F. Terrell, a conductor on a freight train and learned from him that the arrest had occasioned considerable excitement in State Line. He also said yardmaster Jones of the Toledo, Peoria & Western railroad, who is stationed at State Line, visited Kentland Saturday evening and confirmed the truth of the arrest

Revolution in Tucaman.

PANAMA, Aug. 15.—The Buenos Ayres Herald thus describes the late military riot in Tucuman:

"It was reported on June 5 that a revolution had occurred in Tucuman; that the Governor had been deposed and that the city was in a state of siege."

Later advices say: "After a tenacious resistance the revolution has triumphed. The Governor and his Ministers are prisoners. There was a fight for more than twenty hours, Great satisfaction is felt all over the

The Governor on hearing what had occurred went to Dr. Zavala's house for protection. He remained there for some hours and then passed to the opposite side of the block, where he was besieged by the people, and he appears to have surrendered with his m.nisters. It is said that the ordinary business of the city was not interrupted except in the locality where the fighting was going on.

Tolebo, O., Aug. 14,-The sale of a wife for a glass of wine has created a sensation here and resulted in the arrest of Eugene Severy, of Susquehanna, Pa., and W. S. Cowell, of South Valley, N. Y. The girl who was sold claims that she was abducted from the home of her grandmother and says that she was a member of one of the wealthiest families in Susquehanna. She claims that she was drugged and that when she became concious she was in Cleveland, O. She joined Eugene Severy, an adventurer, and he, be coming tired of her, as she alleges, sold her to W. S. Cowell, of South Valley. She has appealed to the police and the detectives are investi-

Gallant Rescue by an Old Man.

KANSAS CITY, Mo., Aug. 14.-The three year-old child of John McGlinn, of No. 584 Armstrong street, yesterday fell into a cistern which is sixteen feet deep and contains about twelve feet of water, Michael McNamara, the child's grandfather, immediately plunged in. The child had sunk twice and was just coming up to the surface when he caught it by the neck. McNamara went under twice, but by a desperate effort he caught a slender piece of clothesline hanging in the cistern. With one hand holding the child and the other grasping the rope he kept above water until a fireman arrived with a ladder. McNamara is about seventy years old and was suffering with a broken leg.
