Mrs. Eddy has indeed, explained this, with her usual marvelous clarity, on page 126 of Science and Health, where she writes: "The point at issue between Christian Scince on the one hand and popular theology on the other is this: Shall Science explain cause and effect as being both natural and spiritual? Or shall all that beyond the cognizance of the material senses be called supernatural, and be left to the mercy of speculative

Now what a man demonstrates is always his own knowledge of anything. If his knowledge is purely material, he soon discovers that his premises are changing, for the very simple reason that there is no Principle in them. The verification of this is written in a milion textbooks, from the ethics of Arisotle to the Summa of Aquinas, and from the theories of Abelard to the speculations of Kelvin, themselves nothing but a mental Sahara of hifting sands. But if a man has caught one glimpse of the spiritual, he has found the rock of Principle, and his knowledge will begin to expand, just as the dawn broadens into day. How scientific this knowedge is, he will discover by the ease which he will be able to
