GROWERS THEMSELVES MUST LEAD FIGHT

Reviewing the meeting of the American Cotton Association at Montgomery last week. The Progressive Farmer of September 11, an advance copy of which has been sent us, sets forth six things that can be done to help get better prices for the South's biggest crop. They are:

- 1. First and foremost, hold your cotton.
- 2. Go to your county mass meeting Wednesday, September 15.
- 3. Cut your cotton acreage next year by sowing a record-breaking grain crop.
- 4. Put your cotton in a warehouse and organize a cooperative marketing association.
- 5. Do all you can to help men who are in a tight place financially from having to sacrifice their cotton.
- 6. Demand a fair price for cotton seed.

The Progressive Farmer closes with the assertion that "if this battle for better cotton prices is to be won, the growers themselves must fight to the finish."

Quite true, but if the growers will only convince the rest of the South that they mean business, they'll not have to do their fighting alone. There must be some way of convincing those millions whose prosperity is so dependent upon the price of cotton that low cotton means trouble and lots of it for every business in the South.

While somebody is finding it everybody might turn out to his county mass meeting Wednesday of next week and see if there isn't some place he can catch hold.

NEWS AND OBSERVER'S REPORT IS SURELY REFRESHING

The candor with which the News and Observer reports a singular lack of interest on the part of Eastern North

Carolina in politics is decidedly refreshing.

The Old Reliable is not want to be so frank this close to an election, or to exercise so much care in making a political diagnosis. It would have been quite as much in character for it to have reported much interest on the part of the Democrats and all "sickness and other uneasiness on the part of the Republicans."

But the News and Observer does not wholly free itself from its campaign year traditions. Right on the heels of what we assume to be a correct estimate of the lassitude of the countryside comes the time worn, if not time honored, wheeze about the "resentment" being shown by "respectable Republicans" against Marion Butler's assumption of leadership, as if The Old Reliable admitted the respectability of a sufficient number of Republicans to make it necessary to hold an election.

Whether Marion Butler is leading the Republicans of North Carolina or not, we don't know and have never made up our mind as to whether we would care if we did know. But we'd gamble that the News and Observer is equally uninformed and that it has found this "resentment" against Mr. Butler in its files of previous campaign years, rather than met up with it recently.

At a time when the Democratic party in North Carolina has begun to accomplish something in education, health and taxation, wouldn't it be just as good politics and in just as good taste for those of us who are going to vote the Democratic ticket this fall to spend our time airing our reasons for so doing, rather than to devote our efforts to stirring up strife among the poor, misguided members of the minority party?
