## AL SMITH TO MAKE SIX SPEECHES FOR ROOSEVELT TICKET

Engagements Tentatively  
Arranged For New Eng-  
land, New York and  
New Jersey Cities

FIRST TO TAMMANY  
ON NEXT WEDNESDAY

Will Speak At Boston and  
at Providence, and Later in  
Albany or Troy; Final Ad-  
dress Will Be In Buffalo;  
Announcement From  
Smith's Office

New York, Oct. 13. (AP)—A tenta-  
tive schedule under which former Gov-  
ernor Alfred E. Smith would make  
six speeches in behalf of Democratic  
state and national tickets in New  
England, New Jersey and New York  
state was announced at his office to-  
day.

The first announcement was merely  
that the speeches would be made, but  
it was shortly followed by another  
statement that the whole program  
was only tentative.

Smith's first speech under the ten-  
tative program will be delivered in  
Tammany Hall, New York City, Octo-  
ber 19, it was said. The next date  
announced is awaiting word whether  
the program can be obtained that  
night, October 24 in Newark, N. J.  
Former Governor Smith is schedu-  
ling to go into New England on  
October 27, making speeches in Bos-  
ton and Providence, R. I., that day.  
Another speech is to be made Octo-  
ber 28 somewhere in the Albany dis-  
trict, possibly in Albany or Troy. The  
next address listed in the announce-  
ment is set for Buffalo on October 29.  
The announcement, which was the  
first public statement out of Smith's  
office since his public reconciliation  
with Franklin D. Roosevelt, Demo-  
cratic presidential candidate in Al-  
bany at the state convention October  
7, did not specifically state what will  
be the subject of Smith's speeches.

## Leroy Lee To Go To Electric Chair On Murder Count

Raleigh, Oct. 13. (AP)—LeRoy  
Lee, Guilford county Negro, con-  
victed of the murder of A. B. An-  
drew, of Sedalia, will be electro-  
cuted tomorrow at State's Prison  
here unless there is a last minute  
change of time.

Tyre Taylor, executive counsel,  
said after hearing counsel for Lee  
this morning that nothing had  
arisen to lead him to recommend  
clemency for the man. Governor  
Candler has indicated he will not  
interfere.

Lee and Nord Donnell were  
initially convicted of the murder of  
Andrew. Donnell was electrocuted  
some weeks ago.

In his cell on Death Row, Lee  
today reiterated his innocence.

## TROOPS SENT TO EXAMINE REPORTS

Taylorville, Ill., Oct. 13 (AP)—  
Troops hurried into the country  
today on a report that 200 strikers  
had looted a barn with ammunition.  
They men fled from the barn, but  
were nearly all captured after an ex-

## Ehringhaus To Resume Campaigns

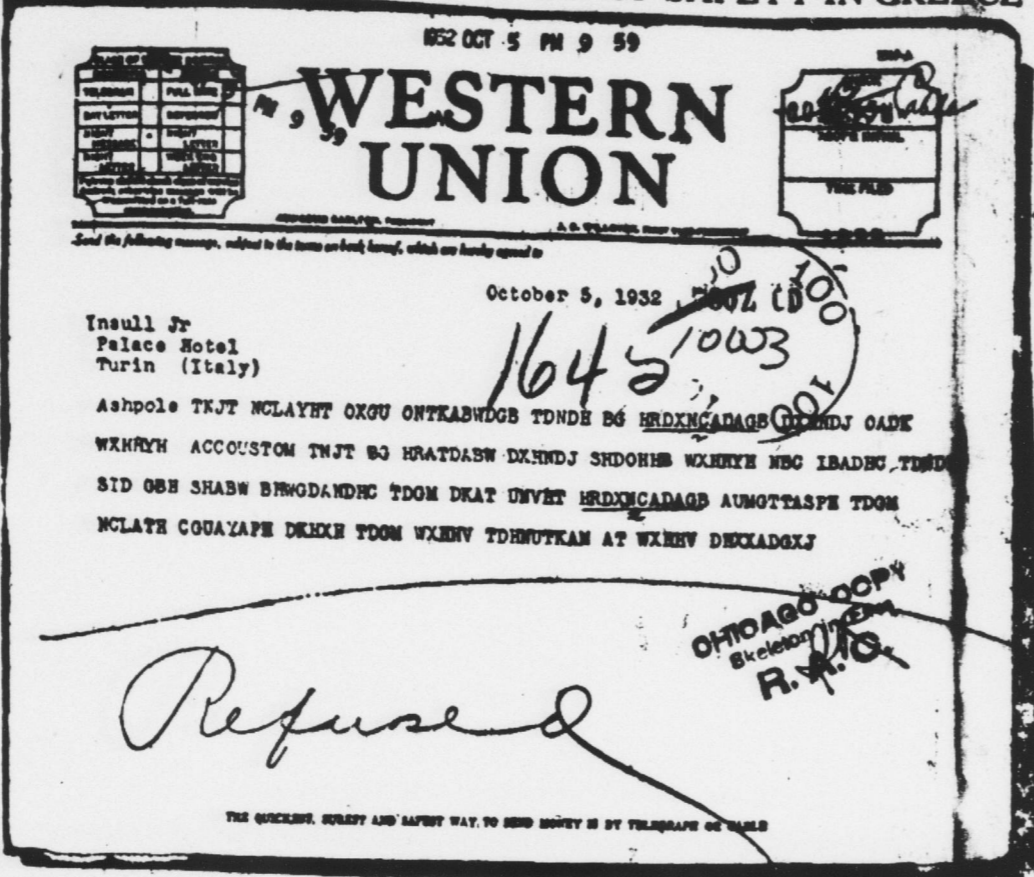
Notifies Randolph  
Party Leaders He  
Will Be In Asheboro  
Friday Night

Asheboro, Oct. 13. (AP)—John C. B.  
Ehringhaus, Democratic gubernatorial  
nominee, was so much better today  
after an attack of chronic appendicitis  
that he decided to keep a scheduled  
speaking engagement at Asheboro to-  
morrow night.

Earlier in the week, when he was  
confined to his bed here, under phy-  
sician orders that he might not get  
out of bed at all, Ehringhaus can-  
celed his Asheboro date, but today he  
declined Randolph county party lead-  
ers to go ahead with plans, as he  
would be there.

Mr. Ehringhaus will speak in  
Asheboro at 8 p. m. at Lexington, and at  
Mocksville.

## CABLE TELLS SAMUEL INSULL OF SAFETY IN GREECE



This is one of the four coded  
cablegrams sent to Samuel Insull  
from Chicago which has been  
presented to the Cook county  
grand jury. It was addressed to  
Insull's son, Samuel, Jr., who ac-  
companied his father part of the  
way on his flight from Paris to  
Athens where he was arrested.  
The former multi-millionaire util-  
ity king faces indictments charg-  
ing larceny and embezzlement.  
The cablegram, without signature,  
deciphered, reads: "Gilbert E.  
Potter says advices from Wash-  
ington state no extradition treaty  
with Greece. George L. Cooke  
says no existing treaty between  
Greece and the United States, but  
being negotiated. This makes ex-  
tradition impossible. Advise don-  
icille there. Greek steamship is  
Greek territory." The message is  
dated Oct. 5.

### Chinese Slayer In Harbin Lynched

Harbin, Manchuria, Oct. 13.—  
(AP)—An infuriated crowd last  
night lynched the Chinese bandit  
accused of killing Mrs. C. T. Wood-  
ruff, an English woman, yesterday,  
as she tried to prevent the kid-  
naping of her three children.  
The bandit was strung on a tree  
where the kidnaping occurred.  
Later his head was cut off and  
put on a table as an example.

### SAYS REPUBLICANS SEEK PANIC ALIBI

Franklin, Ind., Oct. 13 (AP)—Jose-  
phus Daniels, secretary of the navy  
in president Wilson's cabinet, here last  
night declared republican campaign  
strategists were trying to prove "an  
alibi" for what he called "the Hoover  
panic." The Raleigh, N. C. publisher  
made his assertion in a Democratic  
campaign speech here.  
"In their desperation as the cam-  
paign reaches the home stretch, the  
republican orators, from Calvin Cool-  
idge down to township spellbinders  
are speaking over-time in the hectic  
attempt to prove they were not here  
when the Hoover panic struck agri-  
culture, industry and commerce,"  
said Daniels in his prepared text.

Martin Tells How Stand-  
ards for Schools Were  
Agreed Upon

Raleigh, Sept. 13.—Vigorous answer  
to a number of mis-statements with  
regard to the budget limitations im-  
posed by the State Board of Equiza-  
tion as made in an editorial in the  
Greensboro News of Monday, Octo-  
ber 10, is made by LeRoy Martin,  
secretary of the board in a letter to  
The News which he made public to-  
day.

The editorial states that what is  
known as the "state standards" of cost  
in the maintenance of schools, which  
is used by the board in determining  
budgets and in making allotments of  
State funds came into existence more  
or less accidentally as the result of  
the efforts of the Board of Equaliza-

"Gentlemen, I Am Glad To  
See You," Is President's  
Greeting to Group  
In His Office

### DEMANDS FOR HELP HANDED EXECUTIVE

Clothing, Cots, Mattresses  
and Blankets, Plus 15  
Cents Daily for Food Are  
Asked for Ex-Service Men;  
Shown Every Courtesy,  
Leader Asserts

Washington, Oct. 13. (AP)—Presi-  
dent Hoover today received personally  
a delegation from the bonus expedi-  
tionary force after its leader, Hoke  
Smith, had conferred for more than  
an hour with one of the President's  
secretaries.

Frank T. Hines, director of veterans  
affairs, stood beside the chief execu-  
tives desk as the B. E. F. delegation  
filed into Mr. Hoover's private office.  
Those in the lobby outside could hear  
the President say:

"Gentlemen, I am glad to see you."  
Smith placed upon the President's  
desk a petition asking that members  
of the B. E. F. be given clothing, cots,  
mattresses and blankets, and a food  
allowance of not less than 15 cents a  
day.

Two women were in the delegation.  
"We were received by the President  
and shown every courtesy," Smith  
told newspaper men as they left the  
White House.

"We gave our petition to General  
Hines in the presence of the Presi-  
dent. We pledged our unwavering al-  
legiance to the Constitution and the  
Flag," Smith said.

### MYSTERY SHROUDS DRY AGENT'S DEATH

### Body of Chicago Man Found Shot Twice; Companion Held By Police

Chicago, Oct. 13 (AP)—A baffling  
mystery confronted the authorities  
today as they sought further details  
of a fatal shooting of which Carl H.  
Reese, 45, former prohibition agent,  
and reputedly wealthy race horse own-  
er and bookmaker was the victim.

Reese's body, punctured by two bul-  
lets, was found near Libertyville Lake  
yesterday.

Louis L. Howell, suburban politi-  
cian, was held by Lake county offi-  
cials while they investigated the af-  
fair, Howell said he and Reese were  
forced to halt by four men in an au-  
tomobile, and that the four fired  
several shots at Reese. Two of the men  
Howell said, got in his car and forced  
him to aid in disposing of the body.  
The men, their own car following  
forced him to drive to Chicago, he said,  
where the pain in his car got out and  
disappeared with their companions.

Because of discrepancies in Howell's  
story, police said he was held for fur-  
ther questioning.

### Madison County Slayer Suicides After Arrested

Asheville, Oct. 13.—(AP)—Death  
will keep Leo Franks, 22-year-old  
mining youth, from going on trial for  
the murder of his brother's 18-year-  
old wife.  
Franks died in a hospital here last  
night from a gun shot wound he gave  
himself after shooting his sister-in-  
law in Madison county Sunday.  
Fear of mob violence resulted in  
his removal from the Madison county  
jail.  
From there he was taken to a hos-  
pital, where an emergency operation  
failed.

## GREEK GOVERNMENT MAY INQUIRE INTO INSULL DETENTION

Former Utilities Magnate  
May Have Been Held  
Without Proper Au-  
thority In Athens

### HE MAY BE ASKED TO LEAVE SHORTLY

He Is Believed To Have No  
Intention of Returning to  
America Voluntarily; Con-  
templated Creditors' Ac-  
tion Here Would Prove  
Revelation

Athens, Greece, Oct. 13.—(AP)—  
Samuel Insull, under indictment  
in Chicago in connection with the  
collapse of his utilities interests,  
refused to day to surrender his  
passports to the American consul  
until after he had consulted his  
lawyer.

The attorney continued to re-  
fuse any statement on the case  
for publication.

It was said at the American Leg-  
ation that the staff was without  
official notification in writing of  
Mr. Insull's release from deten-  
tion or the reason for his release.

Chicago, Oct. 13 (AP)—Samuel In-  
sull, Sr., and his brother, Martin, to-  
day were faced with personal bank-  
ruptcy action as creditors sought to

## Stone Laid At Home Of High Court

Hoover, Hughes and  
Bar Head Dab Mor-  
tar on Marble; John  
W. Davis Speaks

Washington, Oct. 13.—(AP)—In the  
presence of a distinguished audience  
of the judiciary and the American Bar  
Association, the cornerstone for the  
new home of the United States Su-  
preme Court was laid today, with  
President Hoover officiating.  
After he had handed the tiny  
trowel, while rain fell softly, he pass-  
ed it to Chief Justice Hughes, who  
also dabbed mortar on the huge mar-  
ble stone; and then stepped aside for  
Guy A. Thompson, of St. Louis, presi-  
dent of the bar association, to do the  
same.

Beginning while John W. Davis was  
delivering an address on behalf of the  
bar and the Supreme Court, the drizzle  
continued throughout the brief cere-  
mony, held across the plaza fronting  
the Capitol. All members of the Su-  
preme Court, save Louis D. Brandeis,  
were present.  
Attorneys attending the annual  
meeting of the American Bar Asso-  
ciation composed the larger part of the  
audience that watched the ceremony  
at the partially completed structure.
