That Barnes was beaten unconcious by Arthur Rape, camp steward the night they were taken out of solitary confinement, because Barnes spit on the floor. Rape used a heavy cane in beating him.

That they were kept in Captain Little's camp for eight days after being removed from solitary before being taken back to Captain Brown's camp and that during those eight days, de spite the condition of their feet, Dr McLaughlin visited them and looked at their feet only twice.


