5,264 Register Here For **Coming Primary Election**

211 of Total Are Republicans; 3,418 Democrats Registered in Henderson Township, With 103 Republicans.

A total of 5.264 persons registered for the May 25 primary during the two weeks the books were open, endtwo weeks the books were open, end-ing at sunset last Saturday, A. W. Gholson, Jr., chairman of the Vance County Board of Elections, announc-ed today. No tigures were available to show the registration on the old books, but the total put on in this new countywide registration is almost as much as the vote Vance county has cast in primary elections for the past several bienniums.

Some believe that most of those who registered will vote, as the names enrolled represent citizens who are now residents in the county, and who probably would not have qualified had they not intended to vote. Of the total registration, 5.053 are Democrats and 211 Republicans. In Henderson township, where five of the thicteon precincts in the county ire located, 3.418 Democrats and 103 Republicans registered. 

OLD DEED RECORDED DURING WEDNESDAY


