

NYA Officials Arrive To Open Area Office Here

F. A. Waters To Be Area Director

Newly - Created Area Agency to be in Operation by First of Next Week; Office in Horner Building.

Area officials of the National Youth Administration, who will open the recently-created Area No. 2 office in Henderson, arrived in the city today and began preparations for setting up the new agency.

Frank A. Waters, who comes from Asheville where he has been acting district representative of the NYA, will be area director in charge of the area under the Henderson office.

Mr. Waters has been connected with the National Youth Administration since March, 1939, and for four years previously he was connected with the United States Treasury accounts office in Raleigh. Before coming to Asheville, he was with the training division of the NYA in the Raleigh office.

Other officers to be connected with the area office here include Alfred A. Williams, area vice president, formerly of Winston-Salem; Miss Helen Holman, formerly of Oxford, who will be area girls work supervisor; Miss Virginia Pettit, formerly connected with the NYA in the Raleigh office; Miss A. Cooke, of Raleigh, who will be area technician; and Miss A. C. Brown, of Henderson.

has been employed as area health nurse, and Mrs. Lucy T. Allen White of Lonsburg will come to the new office as placement officer. Additional employees to complete a staff of 20 will be assigned in the near future, Mr. Waters said. In this connection, Miss Mary Winn Abernethy, state personnel director, will hold oral examinations tomorrow at the Henderson high school for a number of applicants for positions with the new agency.

Officials of the new NYA office will be housed in the Horner building on South Garnett street where two rooms have been remodeled and furnished for them. Records and equipment for the office are expected to arrive during the week and the staff expects to have the agency in full operation by the first of next week.

Jenkins Wins Honor

Stores Close Wednesday Afternoon

Fifty-seven Henderson retail stores will close Wednesday afternoon at 1 o'clock to remain closed for the balance of the day, inaugurating summer closing hours which will be in effect during the months of June, July and August. Store hours for other days will be unchanged, so far as is known.

Most of the physicians and all of the dentists of the city will close their offices on Wednesday afternoons during the summer, their action in this matter having been taken independently of the store-closing proposal sponsored by the Chamber of Commerce.

Young, secretary of the Chamber of Commerce, said that notice of the closing, with names of the stores to be included, will be published tomorrow, and he said that if any additional stores wish to be included in the notice they should notify the Chamber of Commerce today or early tomorrow.

Vance Vote Unanimous For Quotas

Twenty-seven of the 69 wheat producers of Vance county who were eligible to vote Saturday in the nationwide wheat marketing quotas referendum cast their ballots unanimously in favor of restrictions, it was announced today at the office of County Agent J. W. Sanders.

Six votes were cast at the Henderson polling place and 21 votes were cast at Townsville.

In a nation-wide straw poll taken in the nation as a whole, substantially more than the necessary two-thirds majority of those voting favored the marketing quotas, giving the Agriculture department authority to tell farmers how much wheat they can sell or feed this year and to collect a penalty of 40 cents a bushel from those who do not comply.

As a consequence, growers were assured of a government crop loan for wheat at 45 per cent of parity, or about 97 cents a bushel, compared with last year's loan rate of 36 per cent of parity, or about 72 cents. Legislation recently approved authorized the higher loan in the event quotas were approved.

The fourth annual Boys Camp, sponsored by the Henderson Kiwanis club, opened today at Camp Balance Rock with twenty-eight campers and seven counselors.

The cooking equipment used by the camp is owned by the Kiwanians and each camper is required to bring his own blankets, a canteen, a good time, and a big appetite. Ed Jenkins, local colored man, is cooking for the camp.

J. Fred Kibpatrick, high school coach and teacher, is director of the camp and is assisted by Billy Hight, bugler; Jerry Falkner, athletic director; Billy Daniel, activities; Jimmy Johnson, James Patterson, and Paul Blake, regular camp lifeguard. Plans are underway to teach the boys to swim and dive, nature study, athletics. On Friday night the campers will stage a program in the council ring for the Kiwanians who will hold their regular weekly meeting at Balance Rock. Each member of the club is sponsoring the week's camping for one of the boys.

Camp Balance Rock is open each day to swimmers and picnickers, and indicates as are that the camp will have one of its best seasons in recent years.

Vance Farms To Be Checked Soon For AAA Compliance

Checking of Vance county farmers' compliance with the agricultural conservation program and with the marketing quotas act will begin within the next few days, it was stated today at the office of County Agent J. W. Sanders. A few farmers in the county have already notified the compliance office that they have finished planting tobacco and cotton and these farms will be checked immediately, it was said. Other farms will be checked as rapidly as possible.

A corps of compliance supervisors, who recently attended a course of instruction in Henderson or attended compliance schools elsewhere, includes members who have already been approved by the state AAA office or are in course of approval there.

Notices will be sent to farmers informing them of the visit of one of the supervisors within a few days of the date of the notice, and farmers are asked to be prepared to proceed with the checking at the time of the first visit to the farm, and to furnish such help as will enable the supervisor to complete the job with the

smallest possible loss of time and efficiency. Attention is called to the fact that administrative expenses of the farm program are deducted from the producers' payments, and that the cost of checking farms is the heaviest expense of administration.

Aerial photographs, showing all farm land in the county, are used by the supervisors in checking compliance, and each field in each individual farm must be checked to determine the total acreage limited to each crop.
