

In almost all the cotton mill cities, towns and villages, the new schedule is the highest ever paid.

# Sentence of Green and Gaynor Affirmed

New Orleans, La., June 3 .- The sentence of the Savannah court in the Green and Gaynor case, involving over half a million dollars fraud in the government contract work in Savannah Northern New England harbor, was affirmed in the opinion handed down by the United States Circuit Court of Appeals.

The sentence is four years imprisonment for each and a fine aggregating

Judges Shelby and McCormick handed down the opinion, which was ou appeal, and Judge Pardee dissented.

The Court's Position. Benjamin Greene and John F. Gaynor, the defendants, appealed on 193 five per cent. effective next Monday in assignments of error. The most interesting of these was the claim that their extradition from Canada, the case which went to the Privy Council of England before being finally tried, was illegal. 




