BRITISH SUCCEED IN TODAY'S DRIVE

 Press dispatches failed this afternoon, reported news coming back from the British fighting line indicating that the British had been notably successful on the northern half of the battle front advancing from three-fifths of a mile to nearly a mile at numerous points. In the southern area of the attack the British right flank encountered the most desperate resistance, a stubborn battle being in progress near the Ypres-Menin road. Apparently today's British attack is in an effort to drive deeper the wedge into the line here.

STATE LAWYERS IN CONFERENCE TODAY

 Salisbury, N. C., Sept. 26--Federal and state officials of New York and North Carolina, who have joined in the prosecution of Gaston B. Means, charged with the murder of Mrs. Maud A. King, remained in conference here today at the office of Solicitor Clement, where they came last night. It is understood that they were going over evidence. Assistant District Attorney cooling of New York planned to leave tonight for that city. It had been expected that further steps might be taken by Means' counsel to get possession of documents seized in Means' New York relations between Peru and Germany has been regarded as probably since August when a German prize court at Hamburg rendered an adverse decision in the Lawton case.

Now, therefore, notice is hereby given that the said Water Bond Ordinance will be submitted to the voters for their approval or disapproval, if a petition is filed within thirty days after the last publication of said ordinance; and that the city will not issue or attempt to issue any Water Bonds until thirty days after the last publication of said ordinance has passed without a petition having been filed or if one is so filed will not issue or attempt to issue such bonds, unless the ordinance shall be approved by the voters of the city. The voters have until the 10th day of October, 1917, to file a petition for referendum.

PERU DEMANDS ACTION AT ONCE

 Lima, Peru, Sept. 26--The government has instructed the Peruvian minister at Berlin to present to the German government a demand that satisfaction be given in eight days for the sinking of the Peruvian bark Lawton. If the demand is not met diplomatic relations will be severed.

The Lawton was sunk inside Spanish waters last February by a German submarine. Peru declared the sinking to be unjustifiable and insisting on the paying of indemnity. The German government offered to leave the matter to a prize court.
