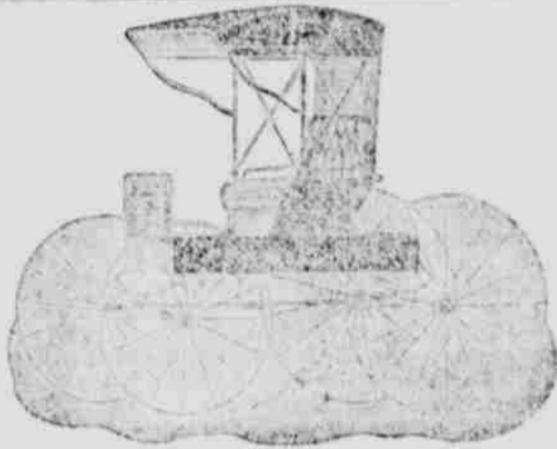

BICKETT'S THREE B'S

Bred, Bacon and Buttermilk Will Not Only Make Germans Take Notice But Do Other Things.

"Germany will take our entrance into the war just as seriously as we take it," Governor Bickett declared Friday in making the commencement address at Bay Leaf high school, 15 miles in the country.

The governor was making the only commencement address which he has accepted anywhere near his home, and one of the very few of any character that he has yielded to. He was preaching against Prussianism, and in favor of "Bickett's three B's, Bred, Bacon and Buttermilk." These he slammed up against Botanic Blood Balm, S. S. S., P. P. The address at Bay Leaf was a combination of war and farming. The first part of it was devoted to discussion of internationalism. He doubted that many present, whether historians or not, could see the trend of world politics. The present conflict, he declared, is to determine whether the world for the next 300 years will be an armed camp and "every civilian shall carry a soldier on his back."

"In this war and in all future wars everybody is going to be treated alike," he continued, showing that not only will democracies be the future governments but these governments will be democratic. Everybody from John D. Rockefeller up is going to be treated alike," he said. "The rich and the poor, the great and the small, and it will make everybody feel better. It has been said that armies move on their bellies and the man with the sword must wait on the man with the hoe.

Best Fed Will Win. "And this war is not going to be won by valor. The present conflict has not produced a race of cowards. Everybody stands up and fights. It will be won by those who are best fed and best equipped, and in that fight all of you can play a soldier's part."

The governor declared that he could propose no better plan of preparedness than an A. B. C. course in farming which he had advocated and the last legislature had ordered for the 98 per cent who cannot attend the farm life schools for their knowledge of agriculture. This course is designed to meet a very pressing need that is statewide. He would point it the best work of the administration if it succeeded in carrying to all spots what a few spots now have, a knowledge of good farming.

He told the story of Moore county, since the harshest spot in his knowledge. When Wake Forest boys came over the seaboard through those desert-like lands the "boys on the train imagined that above all the noise of the travel they could hear the peas on those lands grunting in their mighty effort to sprout," he said. Now Moore is a veritable garden of the goods. Somebody has mixed brains with the soil and made the desert to bloom.

He discussed briefly the impetus given to farmers by the passage of the crop lien bill which encourages the growing of food crops, and the act, if it had been passed a year ago, he declared, would have worked finely into the enforced necessity for more food planting this year. On the southern farmer the world leans heavily today, he said. North Carolina is a great land and the intelligent may go up and possess it.

School Closing at The Trail.

The query was: "Resolved, That the Government should own and operate the railroads of the United States." The affirmative was represented by Henry Garnon, Burdette Crowell and Dexter Orr, and the negative by Murray Simpson, Perry Garnon and Stacy Orr. The judges decided in favor of the negative. On Thursday morning there was a recitation and declamation contest by the advanced classes. The medal for the best recitation was won by Miss Kate Crowell and the declaimer's medal was won by Mr. Samuel Lemmond. I will state right here that Mr. Lemmond also won the medal in the county commencement in Monroe Saturday. Thursday evening the annual literary address was delivered by Mr. David Owens, president of the Chamber of Commerce of Charlotte. Thursday night a play was given, entitled, "A Kentucky Belle." This was attended by the largest crowd during the entire exercises. First-class music was rendered by the Iemorie band Thursday and Thursday night.
