CIDER OUESTION VEXES GREEN AND THE JUDGE

They Ask, Is Cider Going Be Carried Over From 10 Sweet to Sour Stage.

"If it's lawful to make vinegar, how is the cider going to be carried over from the sweet the sour stage without violating the prohibition law?" This is a question that is worrying Editor J. Z. Green and Judge W. O. Lemmond. They discuss the question pro and con at every meeting, and hope to arrive at a favorable decision before the cider season starts in earnest. Should the Judge render an unfavorable decision, Mr. Green will carry the case to the higher court for the consideration of Chief Justice M. L. Flow. In the meantime, he says, no restraining injunctions will be issued, but a man must use his own judgment.
