The Hessian Fly Raiding Wheat Fields—Continental Money—The Work of Thieves—A Big Hog—A Verdict for \$600 Against the Scuthern.

Railroad and divorce cases monopolized the time of the court last week, and the civil docket was not half cleared.

Mr. Jason A. Sherill, of Mountain Creek, killed last week the biggest hog we have yet heard of this year. It weighed 568 pounds and yielded over 100 pounds of lard. The hog was not quite two years old.

The jury in the Duncan case gave \$600 damage against the Southern Railway Company. This is the case in which a man by the name of Duncan was put off the train at Conover. The man fell and died from his injuries.

The people of Mountain Creek township are having to keep things securely locked, and even then thieves are making frequent raids on pantries and smokehouses. Mr. W. J. Holdslaw one night last week lost 18 pounds of beef and Mrs. J. A. Sherill about a dozen cans of fruit.

Since the publication of items about Continental money was started, it has developed that there is much more of it in this county than anybody supposed. Mr. W. P. Frye in looking over the papers of his uncle, Joe Hawn, deceased, for whose estate he is administrator, found a \$70 bill issued in 1779, a \$60 bill and a \$25 bill of same date, also a bill for one-eighth of a dollar dated 1770.

Mr. Geo. W. Rabb had with him Monday several samples of wheat the Hessian fly has been operating on. The original stalks have been killed, but some are putting out shoots from the roots. Whether these will amount to anything, is the question. Mr. Rabb says the fly is much worse this year than last. This year these insects are raiding every field, while last year they worked only in spots.
