Would Collect Government Revenues From Liquor.

Washington Dispatch. Nearly the entire expense of running the government may be met from the income tax and the taxes on whiskey and beer if a bill introduced by Representative Vaughn of Texas is adopted by Congress. The Texas statesman declares that at least \$180,000,000 in annual profits that now go to the brewers and distillers can easily be turned into the United States treasury.

The plan is to place the internal revenue tax on malt and spirituous liquors at exactly the same figures as the tariff duties on these articles. That would produce a condition whereby foreign liquors could come into competition with the products of American distilleries and breweries on an equal basis. The present tax rate on whiskey is \$1.10 per gallon; the imported duty is 2.60 a protection of 1.50 per gallon to the distilleries, according to Mr. Vaughn's calculations. He would put the internal revenue tax at \$2.80 per gallon so that the protective differential in favor of the American distilleries would be wiped out. He figures that more foreign liquors would be imported and less distilled in this country with the result of reducing the liquor making industry of the United States.

Big School Strike.

Pittsburg, April 22nd.—The strike of school children against S. L. Heeter, as superintendent of the city's public school system, spread rapidly today and resulted in one death. A little girl was run down by a street car and killed during one of the demonstrations.

Beginning yesterday when hundreds of children remained away from school as a protest against Heeter, who last Friday was acquitted by a jury of two serious charges preferred by a female domestic employed at his home, the strike gained great proportions today. In all parts of the city thousands of school children paraded the streets, tying up traffic at a number of busy points. Police reserves were called out to maintain order.

Late in the afternoon when the demonstrations of the children had ceased the Pittsburg Board of Education held a meeting at which a committee of seven prominent men was asked to investigate the various alleged charges of immorality against Superintendent Heeter.

Banners of all descriptions, some of them inflammatory, are in evidence all over the city. At a number of points during the day Heeter was banged and burned in effigy.

Business Must be Good.

Asheville, May 5.—The City of Asheville has purchased a new patrol wagon, having bought a 40-horsepower machine for use in carrying prisoners to the city jail. A 30-horsepower patrol was purchased some time ago, but experience has shown that it is not strong enough for the use of the department when the business of the department is good. The old wagon has been sold and the new one is expected to reach Asheville within the very near future.

He went up to Washington, went to the Senate chamber in the capitol and while that hall was packed at the opening of the present Congress he stood up and proclaimed that he was the herald of the Prince of Peace and that he must be heard. They put him out of the Senate chamber quicker than it takes to tell—but the name of George Clemmer went from one end of the country to another—and now when he tells the folks that he will deliver the message that he intended to deliver in the Senate chamber he gets a crowd. They would not hear him in Washington. They heard him in Monroe. The address Mr. Clemmer delivers is, along moral lines and is a very good one, but there are a number of 20-year-old boys over the country who can deliver just as good an address—perhaps a better one—than Mr. Clemmer delivers, but they cannot gather together a crowd like he does. Clemmer has a pretty good knowledge of human nature. He is using that knowledge. He wanted to get in the limelight and he got in.

Liquor Men to Meet.

Louisville, Ky., May 4.—Upwards of a thousand wholesale liquor dealers from all sections of the country are expected in Louisville on Tuesday when the National Wholesale Liquor Dealers' Association assemble for a three-day session. Much of the business of the convention will relate to trade subjects, though the members will consider the Webb bill, which passed Congress over President Taft's veto, as well as the system of regulation the dealers expect to see put in which members of the association endorse.
