

New Congress May Bring Trying Days For President Hoover.

Hoover to be Watched Closely by Friend and Foe—Trials And Worries of New President in Store For Him—Old Leaders at Helm in Both Houses of Congress.

Washington, April 18.—The halcyon days of the Hoover administration are over, for the time being, at least. Monday the 71st Congress met in special session and in its wake will come the inevitable trials and worries of the chief executive.

Political observers, including friend as well as foe, will keep a keen watch upon developments during these next few months which are regarded generally as the trying ones for the new President.

These observers will be especially interested in the practical working out of the experiment initiated by Mr. Hoover of adhering strictly to the constitutional line of demarcation between the functions of the legislative branches of the government.

Few Presidents in more recent history have found that course practicable for invariably congressional leaders have turned to the White House to point the way out of many of their difficulties, particularly where such economic legislation as the tariff and farm relief have been involved.

Already some of the leaders on Capitol Hill, especially in the senate, have sought to draw President Hoover out on the matter of framing the farm legislation, and the attendant developments have furnished a highlight of political activities in Washington during the past two weeks.

From the outset the President made it quite plain that he did not intend to write a farm bill for Congress; that a plan of relief had been laid down in the Republican platform and in his own campaign speeches and that it was the function of Congress to translate this into legislative form.

Unlike his predecessor, Calvin Coolidge, Mr. Hoover finds his party with better than a working majority in the senate, although in that body account must be taken of periodical defections by some of the Republican independents.

Most of the independents supported Mr. Hoover, especially on the farm relief proposal in the campaign, and his friends are counting on that support of this kind of legislation, which is to be the first subject to occupy the attention of the house.

NUMBERS OF NEW MEMBERS BUT LEADERS ALL VETERANS

Washington, April 18.—With the convening of the 71st Congress in extra session Monday, nine new representatives took their seats but in both branches veteran hands will be at the helm to guide the course of the nation's legislature.

Presiding over the senate was Vice President Curtis, its former Republican floor leader and veteran of three decades of service in Congress. Then, by an election upon convening, which was

Sauratown Game Is Well Protected

Arrests Made For Hunting on Preserve Without License—Refuge Being Fenced In.

Danbury, April 13.—That the Sauratown game preserve of 50,000 acres is now recognized as sacred ground for wild game, and that they will be protected to the fullest extent of the game laws has been proven here recently, in the arrest of intruders upon the boundary. The first violations of the hunting laws on the preserve were recently committed and two men, Byron and Gaston Sizmore were arrested, charged with hunting without license on the preserve.

This is not the first arrest for hunting without license, but the first for hunting on the preserve. The new bungalow which will house the game preserve refuge keeper, is rapidly nearing completion. The refuge, which contains 20 acres, is being fenced in with 10 foot wire. This will soon be completed and the refuge keeper will formally take charge of the preserve and keep a watch over the animals entrusted to the refuge, as well as keep a lookout for forest fires.

The boundary wire to the preserve has been strung and other features are rapidly being put into shape. Lake Stradman is being stocked with fish, in keeping with the plans announced sometime ago. Recently a large number of grown fish were released in the lake, and later it is understood large numbers of game fish minnows will be released.

Among the new representatives are three women, who bring to a total of eight the feminine contingent in the house, the first negro to serve in the house in a quarter of a century, and a "baby" congressman, 28 years old Representative Hartley of New Jersey. Two of the new women representatives have political ambitions by inheritance. Mrs. Ruth Hanna McCormick, an Illinois Republican, is the widow of the former Illinois senator, Medill McCormick, and granddaughter of the late Mark Hanna, for many years leader of the Republican party. Ruth Bryan Owen, Democratic representative from Florida, is the daughter of the late William Jennings Bryan, off-time Democratic presidential candidate. The third new woman representative is Ruth Baker Pratt, Republican, New York.

The five women members of the 70th Congress who will continue in the new Congress are Mrs. Edith Nourse Rogers of Massachusetts; Mrs. Katherine Langley of Kentucky, and Mrs. Florence P. Kahn of California, Republicans, and Mrs. Mary T. Norton of New Jersey, and Mrs. Pearl P. Oldfield, of Arkansas, Democrats. Mrs. Oldfield was elected to the second session of the last Congress after the death of her husband, Representative William A. Oldfield, Democratic whip.

The negro member of the house is an Illinois Republican, Oscar DePriest who succeeded to the seat of the late Martin B. Madden, for many years chairman of the powerful appropriations committee.

Tar Heel Republicans The new house membership will also include five Republican representatives from normally Democratic "solid south" states who gained their elections in the landslide victory of President Hoover. Three of these, Menaloune Lankford, J. A. G. 'ter and Joseph C. Shaffer, are from Virginia, while the other two are Charles A. Jonas and George M. Fritchard of North Carolina.

Police and river men were searching for bodies but the flooded condition of the stream balked their efforts.
