GREENVILLE SCHOOLS OPEN.

Greenville, Sept. 8.—The local white public schools opened yesterday with an attendance of more than 500.

FARMER HELD FOR RETAILING.

Lonnie Harrison, a white planter of the Pink Hill section, was sent up to Superior Court by Magistrate H. C. V. Peebles at the courthouse Monday evening on the charge of selling whisky. A bond of \$100 was required.

GREENVILLE MAN POSTOFFICE INSPECTOR.

Greenville, Sept. 8.—John W. Shelburn, assistant postmaster here, has been appointed to the position of inspector. His efficiency had attracted the attention of Congressman Small.

SLAYER TAKEN TO GRIFTON.

Joe Daniels, the negro who shot up a restaurant at Grifton Saturday evening, killing Levi Morris, colored, and wounding another negro, has been taken to Grifton for a preliminary trial, and later will be confined in the Pitt county jail at Greenville.

MEETING AT ARMENIA CHURCH

Rev. C. W. Howard will begin a protracted meeting at Armenia church next Sunday. Mr. Arthur Wake, who is conducting the music in the evangelistic meeting in the Christian church here, will have charge of the praise service, and will do the preaching.

HEAVY FINE FOR FALSE ALARM

City Council Monday night adopted an ordinance making the ringing of a false alarm or tampering with an alarm box or other fire department equipment punishable by a fine of \$50, or imprisonment for thirty days. The mayor was empowered to offer a reward of as much as \$50 for evidence to convict a person who violates the ordinance.

LINCOLN CITY WANTS POLICEMAN.

Residents of Lincoln City, the negro suburb, southeast of the city, have applied to the authorities for police protection from a rowdy element, which it is claimed infests suspected houses in the village. Lincoln City, the protestors say, is a respectable community with the spirit for civic betterment, but the law-abiding residents are unable to keep out the chaff which flocks there.

KINSTON'S TAX LEVY IS UNCHANGED.

The city tax rates for 1914 were announced from City Hall today. The levy is identically the same in total as last year's. The items follow:

General city fund, 40 cents; bonded interest fund, 31 cents; sinking fund, 5 cents; school bonds account, 9 cents; general school fund, 30 cents; school poll, 90 cents; city poll, \$2.

The general school and school poll assessments were made by the Board of Aldermen upon the recommendation of the school trustees.

INTERESTING MEETING AT GRAINGER'S.

Rev. S. W. Sumrell reports having just closed an interesting meeting at Grainger's Station, in which five new members by baptism were added to the church there. The meeting started the last Sunday in August, and ran for a week. Splendid crowds attended. The congregation at that place expect to erect a church building in the future. Mr. Sumrell says the Sunday school, under the leadership of Mr. Hamilton, is flourishing.

Mr. Sumrell will start another meeting at Bethel on the fifteenth.

SCHOOLS TO GRADE WEDNESDAY.

Grading in the city schools preparatory to beginning the fall term on Monday will be commenced Wednesday, when children of the primary ages will be given their cards. On Thursday the grammar and high school grading will take place. The principal of the high school will confer with pupils in his charge Thursday morning at 9.30, at the high school building. All pupils who were "conditioned" on any subject last year and who wish to take an examination to remove the condition, must be on hand then.

TRAINMEN DISLIKE KEYES' APPOINTMENT

Trainmen of the Beaufort district of the Norfolk Southern Railroad do not relish the recent appointment of John W. Keyes to be trainmaster of the district. Keyes came from the Raleigh district, and is believed to have been the selection of District Superintendent John C. Lewis. New Bern will be Trainmaster Keyes' station.

Employees in the district claim that there are a number of men in the district with more service on the system than Keyes, and cite that custom usually gives the preference to men within the territory when promotions are to be made. Keyes came to the Norfolk Southern from the Middle West, and has been running passengers from Raleigh to Washington. His efficiency is not doubted by the Beaufort district men, and their dissatisfaction is based solely on what they call the unfairness of Superintendent Lewis.

ODD CASES BEFORE JUDGE OLIVER ALLEN

Some unusual cases were pulled off in Columbus County Superior Court, over which Judge Oliver Allen of Kinston was presiding at Whiteville recently.

Kitty Cartrett, who is over 98 years of age, and Florence Cartrett, aged 57 years, pleaded guilty to selling wine. They were required to pay the costs.

F. M. Creech, a blind white man, pleaded guilty to manslaughter. He shot John W. Allen, a negro, while Allen was killing a snake near the Creech home. There was evidently no criminal intent. After an eloquent plea for mercy by counsel, Judge Allen gave Creech the light sentence of four months.

The civil docket of the court was laid over because of the inadequacy of the Columbus court's temporary quarters.

"John L. Sullivan and James J. Corbett. Grand glove contest for the heavyweight championship of the world, at the Olympic Club, Wednesday, September 7, 1892, 9 o'clock p. m. Purse, \$25,000."
