





Nationality of Eggs.

Is it possible to tell the nationality of an egg by inspection? The question is raised in acute form by the evidence given by the prosecution of a Lancashire, England, firm for selling Russian eggs as Irish, which resulted in acquittal. The experts varied, as even experts will. On the other hand, experts for the defense were equally positive that nobody could tell the birthplace of an egg from external examination. One witness said that when eggs were bad their nationality was indeterminable.
