 ciency.A recent investigation made by the U. S. Public Health Service in
connection with studies of rural school children showed the 49.3 per cent had defective teeth, 21.1 per cent had two or more missing teeth, and only 16.9 per cent had had dental attention. Over 14 per cent never used a tooth brush, 58.2 per cent used one occasionally and only 27.4 per cent used one daily Defective teeth reduce phssiza efficiency. Dirts, suppurating snaggle toothed mouths are re sponsible for many cases of heart disease, rheumatism, and othe chronic affections. The children are not responsible for the neglect ed state of their teeth. The ignorant and careless parent is to blame for this condition-a condition which bampers mêntal and physica growth and puts a manent han dicap on our future citizens. Schoo teachers can and are doing much in inculcating habits of persona cleanliness on the rural school child but this will fail of the highest ac complishment unless parents co operate heartily and continuously.
