J. A. LAUGHRIDGE PASSES

Popular Ex-Sheriff Died Suddenly Thursday Evening-Funeral Services Sunday.

The people of this community and the entire county were greatly shocked to learn of the sudden death of Ex-Sheriff John A. Laughridge, which occurred about 10 o'clock Thursday night. He was in his office in his usual spirits during Thursday, no one of course thinking that the end of the venerable officer was so near. His illness was of only a few minutes' duration. He had retired, and his wife, upon coming to his bed room, found him struggling for breath. In a few seconds, before anyone could reach him, he had passed away.

Sheriff Laughridge was a man of powerful physique. He had always enjoyed the best of health. Descended from a family of sturdy stock, remarkable for long lives, he could have reasonably expected, barring accidents, to have lived many years more. The cause of his death is unknown.

About sixteen years ago he was elected county commissioner and has continued in office since that time, serving several terms as register of deeds and the last eight, years as sheriff of the county. As an officer he was dilligent and assiduous in the performance of his duty. His integrity and honesty have never been questioned or doubted. The fact that he was never defeated in a close county bespeaks the high esteem in which he was held, not only by his own constituency but by his political opposition.

As a friend and neighbor John Laughridge was loved by all. His home was always open to bis many friends and his pocket book to anyone in distress or want. Many a poor widow has been helped by this kind man in his plain, unassuming way -the world knowing Davis, D. J. Chapman and C. R. nothing about it. He was a great McCall.
