

> GAS REFUND County Agent Charles D. Raper reports that Columbus County farmers are entitled to approximately a quarter of a million dollars in tax refunds on gasoline used in farm tractors since July 1, 1960.

In order to receive a refund farmers must fill out Form 2240, Claim For Refund of Federal Tax for Gasoline Used on the Farm. For each gallon of gasoline used in a tractor during the fiscal year 1960-61, farmers are entitled to a fourcent refund.

Attention is called to an error that was made in the printing of this refund form for 1961. Line 2 (a) should be disregarded, and Line 2 (b) should read as follows: "Purchased from July 1. 1960 through June 30, 1961."

Isoo through June 30, 1961." In order to determine the refund, the farmer should multiply the number of gal-lons used by four cents. The forms have already been mailed to all farmers who filed for a refund last year. For those who did not file, a supply of forms is available at County Ageneta available at County Agent's office. Forms should be completed and mailed be-fore Oct. 1, 1981.
