

NEW MARKET FOR FRUIT GROWERS

Charlottesville, Va., July 15. Virginia apples were sold in the Panama Canal Zone for the first time during the past season the market agent of Southern Railway having put the growers in touch with the purchasing department of the Panama Railroad which supplies food products to the population throughout the Zone. Many carloads of Pippins and Winesaps from orchards along the Southern Railway, north and south of Charlottesville, were sent to the isthmus weekly shipments having varied from 150 to 500 barrels. Despite the tropical weather, the Virginia apples reached Panama in excellent condition and gave such entire satisfaction to consumers that growers have been assured another permanent export market. This new market was particularly valuable to the Virginia growers, coming in a year when prices were relatively lower on account of interference with the usual exports to Europe, and market agent of Southern Railway has received a number of letters expressing appreciation of this practical aid extended to growers.

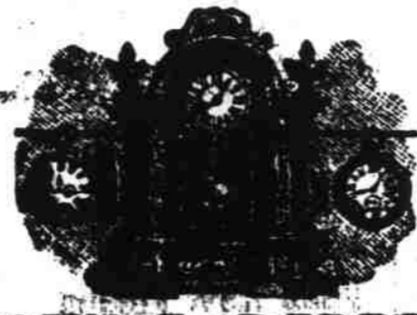
