Section 1. That the Board of County Commissioners of Jackson County is hereby authorized and empowered to issue serial coupon bonds of Caney Fork's Township, in said county, in the aggregate principal amount of not less than Thirty Thousand Dollars, and not more than Sixty Thousand Dollars, in the discretion of said Board of County Commissioners, for the purpose of constructing and improving the public roads of said township, and is also hereby authorized and empowered to levy annually a special ad valorem tax on all taxable property in said township for the special purpose of paying the principal and interest of all bonds the bonds authorized by any other issued under this act, as such prin- act and they shall not be subject to cipal and interest becomes due, which any limitation prescribed by any othtax shall be in an amount sufficient or act. for said purposes and shall be in addition to all other taxes authorized to be levied in said township.
