It is a good idea to have succession plantings of sweete eorn and snjap beans. The sweet corn does best when planted in blocks, rather than in long rows. When there are only one or two long rows in the garden, the corn is poorly pollinated and only a few scattered grains are on the cob as a result."

Planting dates for all vegetables are given in extension circular 122 which is the home and garden manual for North Carolina. Mr. Morrow advises each home gardener in the State to get a copy of this publication and those who have entered the garden contest need it especially, so ::s to make plans for the year around garden.




