Do you think we can float back
to prosperity on a sea of beer?

Banks are opening in North Carolina as fast as Commissioner Howell can pass upon applications.

With real courage once more the heroic in Washington and in Raleigh, the people can look confidently to the future.

The trout season is approaching and the editor still in Raleigh; which does not suit the desires of the editor.

The people demanded economy and their representatives in Raleigh and in Washington are giving them what they have asked for.

In the middle of the second pay less week for the members there is no end in sight to the labors of the Legislature. Nearly all the big bills are yet to be acted upon.

The rest of the country has time much to be thankful for; we did not have an earthquake of considerable proportions to grapple with along with the bank holiday, as did California.

The situation is clearing. The people are taking heart and regaining faith. Business is said to be on a definite upturn, following the banking holiday and the issuance of new currency, which has had much the same effect, as a blood transfusion to anemic patient.

Every Republican member of the House of Representatives, except Oakes, voted against the reappointment of the House under a constitutional mandate. The means would shift a few members from the East to the West. Evidently the Western Republicans don't think so much of the brand of Democracy their section sends to Raleigh.

A revaluation of property is now assured. The House of Representatives has provided for it in the machinery act; but has left it optional with the county commissioners as to whether the revaluation will be done by the appointment of assessors to make a physical revaluation or by percentage cuts.

A bill has been reported favorably out of the House Committee on Counties, Cities, and Towns, to allow the commissioners of counties and municipalities to effect economies at home, as have been effected in State and Nation, by consolidation of jobs, elimination of offices and reduction of salaries. The bill is sponsored by Governor Ehringhaus, who believes in carrying the principle all down the line, from Washington, through Raleigh, to the local governmental units.

A COURAGEOUS GOVERNOR

No matter what one thinks of the wisdom of Governor Ehringhaus' solution of the financial problem of the State, no one can deny that we have a Governor who has courage to say what he thinks, regardless of the popularity of his remarks with his audience.

It took no small degree of intestinal fortitude for the Governor, under present conditions, himself running a temperature of 103, telegrams and letters pouring into Raleigh in opposition to a sales tax, to stand before the joint session of the General Assembly on Monday night and advocate the adoption of that form of taxation.

However, the Governor made it clear that he is opposed to the tax in principle and only advocates it at this time as an emergency measure, with the assurance that if enacted, it be repealed at the earliest possible moment. He saw it as the only solution of the problem at this time; and said what he had to say before a hostile House, and a more favorable Senate.

The Governor stressed the point that the only way to give any appreciable relief to the tax-burdened homes and farms back home is through the elimination of the county and district ad valorem tax for school purposes, through the adoption of a uniform public school system throughout the State for the whole six months, and supported by the State as a whole. And he insisted that the only way this can be accomplished at this time is through the adoption of a sales tax, coupled with great reductions in all expenditures.

Commissioner Maxwell followed

the Governor, the next day, by a statement in the papers advocating the sales tax. Mr. Maxwell, who has always been opposed to this form of taxation, pointed out the fact that revenue of the State has dwindled each day since the General Assembly has been in session, and gave it as his opinion that a sales tax is the only way that the State can meet the situation.

There is still much opposition in the General Assembly to the sales tax, the opposition being largely in the House of Representatives. It is certain that the sales tax cannot pass the House unless it is coupled with the uniform State supported school bill, assuring relief to the payers of taxes on homes and farms in the counties and tax districts of the State, and it is by no means certain at this time that the tax can be enacted, even with the support of the Governor and the assurance of the State supported schools.

How long the General Assembly will wrestle with the problem, nobody can predict.

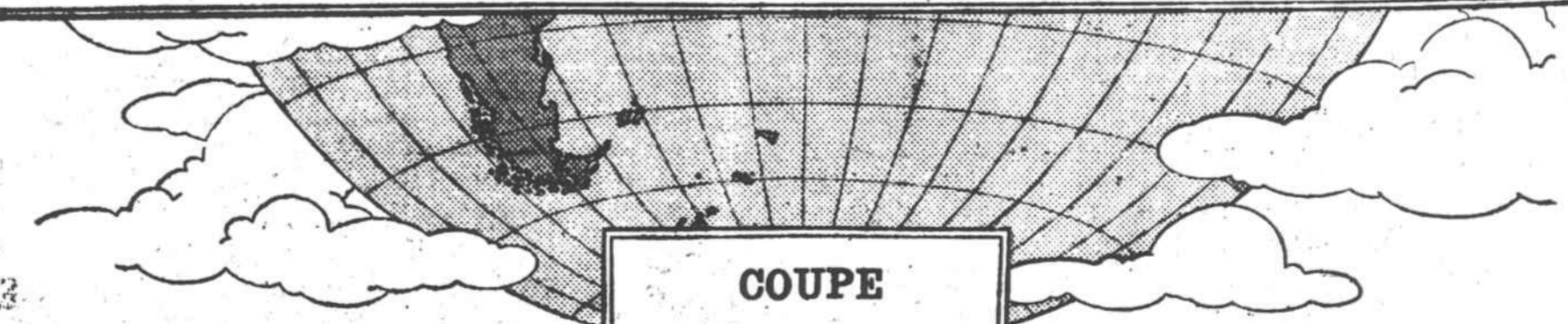
