## 137 Issued So **Far This Year**

During the first five months of 1946, a total of 121 marriage licenses were issued at the office of Register of Deeds W. T. Kirby, a checkup revealed Friday. This total exceeds that for the first five months of 1945 by 36. The total for five months was 85.

Since V-J day last October, the monthly total of licenses issued has been well above comparative totals for last year. A low of 9 was reached during May, 1945, the month during which V-E day occurred. By December, 1945, two months after V-J day, a peak of 42 had been reached-the heaviest total on record during recent years. By years, the totals are: 172 for




