ARRESTS
ALL SUSPECTS appearing on the Person County Sheriff Arrests are innocent until proven guilty in a court of law. All information and photos presented are obtained from public documents and other public sources including police affidavits, court documents and detention records from the Sheriff's office.

REALTY TRANSFERS

In recording the real estate transfers, the law does not require that the amount paid for property be stated in deed. However, the State of North Carolina requires a tax stamp on each deed at the rate of \$2 for every \$1,000 valuation or fraction thereof. This revenue goes into the General Fund of the counties.
