\$100 REWARD.
STATE OF NORTH CAROLINA, EXECUTIVE DEPARTMENT.
Whereas, official information has been received at this department that Jim Booker, alias Jim Chavis, late of the county of Wake stands charged with the murder of Mahaly White, and whereas, it appears that the said Jim Booker, alias Jim Chavis, has fled the State, or so conceals himself that the ordinary process of law cannot be served upon him:
Now, therefore, I, Elias Carr, Governor of the State of North Carolina, by virtue of authority in me vested by law, do issue this my Proclamation, offering a reward of One Hundred dollars for the apprehension and delivery of said Jim Booker, alias Jim Chavis, to the Sheriff of Wake county at the court house door in Raleigh.
