## Sholar.

Sudden Death of Mr. John

Wilmington Messenger. -A telegram received yesterday by Capt. W. H. Sholar, of this city, conveyed the sad intelligence that his brother, Mr. John Sholar died suddenly of heart disease yesterday morn ing at 7 o'clock at Florence, S. C. The remains arrived here last night at 11:15 by way of the W. C. & A. Railroad, and the funeral will take place (probably not before tomorrow) from the First Baptist Church.

The deceased was 64 years of age and was a native of Wilmington. His business was that of a builder and contractor, but he has lately been employed as a carpenter in the Atlantic Coast Line Railroad shops at Florence, whither he removed from this city about a year ago. Some years ago he removed from here to Fayetteville, but he soon left there and for ten or twelve years resided at Raleigh where he followed his trade. He came back to Wilmington about two years ago and after being here about a year he went to Florence to reside. He leaves a wife and two sons, one of whom resides in Tennessee and the other in New York City. The bereaved wife was visiting Fayetteville, but she has arrived here, and probably one or both of the sons will come on to attend the funeral.


"Well, then, if Robespierre wins I'll pay you \$16 a ton for my coal next winter. If he doesn't you will send me my coal for nothing."
