A RALEIGH PATENT.

Mr. L. A. Fort has just secured a patent on an automatic window sash holder, which is doubtless a good thing. Mr. Fort claims for it that it presses the lower and upper sash together in such a way as to prevent rattling and keep the cold air out, while it does not prevent the sash from being raised or lowered at will. We know of nothing much more disagreeable than to be kept awake during a freezing blustery night by the continuous rattle of the sash and finally have to get up in the cold and look up some sticks to wedge the window with. If Mr. Fort has met this difficulty he is a benefactor.

THE CHILIAN WAR ENDED.

Balmaceda was defeated by the Congressional party in the battle of last week, his forces thoroughly scattered and demoralized, and he is reported to have fled the country. Valparaiso and Santiago have both fallen into the hands of the Congressional forces, and it is probable that there will be very little more fighting. The United States is placed in a somewhat embarrassed position, having recognized the Balmaceda's government as the continuation of the government of Chile.

The Colored A. and M. College.

Last Friday the Trustees of the Colored Agricultural and Mechanical College returned to the city from Winston, Greensboro and Durham where they had been examining sites. They report having been received with the greatest civility. In the afternoon they visited the eligible site offered by the people of Raleigh. It is most advantageously situated, comprising about fifty acres, with the prospect of about two hundred acres of admirable farming land. It is only about a mile and a half from the State house on the line of the R. & D. and R. & A. L. Roads. In addition to the land, Raleigh offers, in cash \$7,000. Both will aggregate about \$18,000. It was finally decided to postpone the selection of the site until October, and in the meantime the soliciting committee will make further efforts.

It is but justice to say that our colored citizens have exhibit most commendable zeal in the matter, and it is clear, that the worth and intelligence among them are anxious that Raleigh shall secure the prize.

Up In Ouachita.

THE FARMERS ARE DETERMINED TO DEFEAT THE AMENDMENT.

MONROE, La., 28—At a meeting of the farmers in the fifth ward of this parish today, the following resolutions were unanimously adopted:

RESOLVED, That we denounce and reject as an insult to the virtue and intelligence of our State the proposition of John A. Morris to incorporate into our law an amendment providing for the rechartering of the Louisiana Lottery; that we indorse the action of the representatives of the Farmers' Alliance and Anti Lottery League at Lafayette in entering into a compact for a joint campaign against the lottery.

That we indorse the recent public speeches of the Hon. A. A. Gunby and the speech delivered by him this day

and hail him as an able and earnest exponent of the principles of the Farmers' Alliance and Industrial League.

That the thanks of this meeting be also extended to D. M. Sholars, Esq., Rufus Connelley, Esq., W. R. Womack, district lecturer, and Aleck Benoit, Esq., for the able and patriotic address delivered in our hearing today, and be it further

RESOLVED, That lottery literature, newspapers, circulars, questions of the hour and all lottery trash should be returned in contempt to their issuers.

Austria's Empress Insane.

PARIS, Aug. 30.—A dispatch to the Estafette from Vienna says: The Empress of Austria shows symptoms of insanity. She is very eccentric, desiring bizarre costumes in which to appear in public, and indulging in other oddities.

The Emperor has called in medical experts, who have pronounced the case a grave one, being associated with an hereditary malady. The Duchess d'Alencon, a sister of the Empress, is in an insane asylum at Gratz, and the mad King of Bavaria is a cousin of the Empress.

Impaled on a Bayonet.

FRANKFORT, Ky., Aug. 29.—Harden Davis, of Harrodsburg, a member of a militia company on its way to the regimental encampment jumped, playfully into the air for an apple and in coming down was impaled on the bayonet of a comrade. The bayonet caught him behind the right ear and went clear through his head.

Davis is dying. He was a member of the Buckner Rifles, who were waiting here for a train.
