SELF RESPECT.

The term self respect is too frequently a misnomer in its ordinary use. We heard the subject discussed just a little, yesterday, under the name of pride first and then it was decided that self respect is a better term. At first blush we regarded the decision as correct, but on reflection we have concluded that pride, as commonly used, is the term. Pride, in short, is an over estimate of self, and nearly all, if not all, are guilty of this. Self respect, strictly speaking, is the inner estimate our own consciousness places upon our acts and professions. A man truly to have self respect must necessarily possess an inward consciousness of perfect integrity of purpose. Otherwise he cannot truly respect himself. He may make a very loud profession, and he may be wonderfully profuse in his protestations and all that, and he may demand that all men shall respect him, but unless he is conscious of integrity of purpose in all the outward manifestations of himself, he is obliged to feel that he is requiring more of other men than he can perform himself. That he is trying to pass for what he knows he is not. The man who has constantly to be informing the world around him of his own kindness of spirit and of his large generosity; of how he loves to help the poor; feels so forgivingly toward his enemies, and all that, and yet finds himself annoyed whenever those he chooses to call his enemies, are recognized or spoken of in a kind appreciative way, they green eyed monster has possessed him and he doesn't know it. True self respect is founded on what we know, in our honest hours, of our own motives; not what we would have others to believe them to be, frequently. Self respect is respect for self.

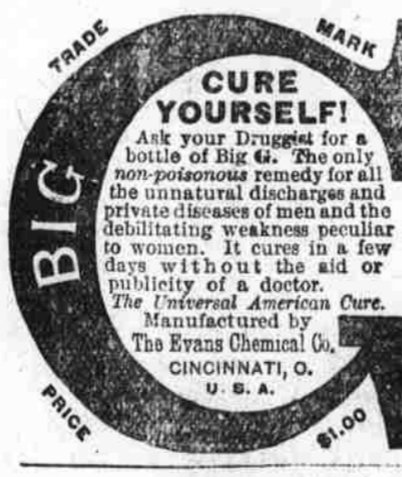
