PROMINENT DOCTOR OF NORFOLK IS IN JAIL

Accused of Performing Criminal Operation on Young Woman
HELD WITHOUT BAIL TO AWAIT HER CONDITION

Dr. L. B. Chiles is the Physician—He is 68 Years Old—Jas. T. Franklin, Car Inspector With N. & W. Railroad, Also Arrested.

Norfolk, Va., Nov. 12.—Dr. L. B. Chiles, aged 68 years, one of Norfolk's most prominent physicians, when arraigned in court to-day upon the charge of having performed an operation, from the effects of which Miss Sarah Atkinson, aged 24, is now reported to be dying in the Norfolk Protestant Hospital, the defendant was committed to jail without bond pending the result of Miss Atkinson's illness.

James T. Franklin, aged 25 years, from Bedford county, Va., and a car inspector in the employ of the Norfolk & Western Railroad, arrested upon a charge of aiding and abetting in the alleged crime, was bailed in the sum of \$1,500 for his appearance in court ten days hence.

Miss Atkinson, in an ante-mortem statement made at the hospital before a magistrate and under oath, first refused to divulge the name of Franklin, but in the end accused the latter, and declared that it was at the residence of Dr. Chiles that the operation was performed.

Dr. Chiles declines to make a statement. He is in a highly nervous condition and fears are felt for him on account of an affection of the heart, which the excitement of his arrest has aggravated.

Franklin denies his guilt, but admits visits to Miss Atkinson for two years.

CLAIMS ROYAL DESCENT.

Chicago Man Declares He is Great-Grandson of George Fourth.

Chicago, Nov. 12.—James L. Ord, of this city, who claims to be the great-grandson of George IV., of England, and Mrs. Maria M. Smyth Fitzherbert, whose marriage was shown to be valid by papers which were opened in London last Friday, declared to-day that he would take steps to claim a share in the estate which it is claimed was left by King George and Mrs. Fitzherbert. Mr. Ord estimates the gross value of the estate at \$125,000,000.

His title to the estate, he says, comes through his father, who is the sole surviving son of a son of King George and Mrs. Fitzherbert. The last mentioned son came in 1810 to the United States, where he was known as John S. Ord.

STABBED THE PRIEST.

Lafayette, Pa., Nov. 12.—While engaged in the celebration of mass at Saint Rose Catholic Church at Brandywine yesterday, Father Shea, the aged pastor, was attacked by John Ravinsky and stabbed in the chest.

Ravinsky, who was in an intoxicated condition, was swearing and disputing with members of the congregation when he was approached by Father Shea, who tried to quiet him, and failing, attempted to eject him. Father Shea came down from the altar to remonstrate with him, when he suddenly drew a stiletto and stabbed the priest in the breast, cutting across the heavy vestments, which caused the blade to glance aside and doubtless saved his life.

Shaw Won't Interfere.

HEGEMAN'S REBATES.

Paid Bankers 4 1/2 Per Cent. and Got Back 3.

New York, Nov. 12.—John Hegeman, president of the Metropolitan Life Insurance Company, was on the witness stand again to-day before the insurance investigating committee.

He presented a statement of rebates paid to Mr. Hegeman on interest on loans on his personal account.

The statement showed that Mr. Hegeman paid Vermilye & Co., bankers, interest at the rate of 4 1/2 per cent, and received in personal checks of various individual members of the firm at different times a rebate of this interest at the rate of 3 per cent. The statement covered a period from June 30, 1922, until this year, when Mr. Hegeman's account was transferred to W. H. Reed & Co. on the dissolution of Vermilye & Co. Mr. Reed was one of the partners in Vermilye & Co.

CHINA IS FRIENDLY.

Mr. Denby Says Boycott Won't Affect Our Commerce.

Washington, Nov. 12.—"The Chinese boycott on American goods certainly cannot be carried to the extreme of seriously affecting our commerce in the Orient," today declared Charles Denby, the new chief clerk of the state department, who recently completed a twenty years official residence in China, and who has arrived in Washington to assume his new office. "At the time I left Peking," said he, "no nation of the world stood higher in China, among government and people, than the United States. Even then China was looking to President Roosevelt to bring an end to the war that was being conducted over its head, and personal advice I have received recently from there indicate great rejoicing among the Chinese over the results of the President's intervention for peace."

STOOD ON HEAD TO DIE.

That Position Stimulated Heart of Poisoned Man.

Chicago, Nov. 12.—A dispatch to the Tribune from Toledo, Ohio, says: After having stood on his head for thirty hours to stimulate heart action, Frank Perry died last night from a large dose of nitro-benzol, taken by mistake for whiskey. In their first effort to assist him, his family discovered that when he was held head down his heart action was strong. So they kept the poisoned man in that position and kept on administering antidotes until he died.

Russian Prisoners Released.

Yokohama, Nov. 12.—Thirteen hundred and seventy-four Russian prisoners, including 1,352 blue jackets from Port Arthur, and one colonel, one lieutenant colonel and eleven soldiers captured at Shimonoseki and Taisan have been released and turned over to the Russian representatives. The Japanese government has provided accommodations for them pending their transportation home.

REV. MASSEE ATTACKS CATHOLIC ORPHANAGES

Believes Roman Church a Great Power for Evil

BIG PETROLEUM OUTPUT

Gain Amounts to 16,602,084 Barrels

Increased Demand Attributed to Its Use in Automobiles—Many New Fields Discovered—Further Increase Indicated.

(By the Associated Press.)
Washington, Nov. 12.—According to a report issued by the geological survey the total output of crude petroleum in the United States in 1924 was 1,011,170,466 barrels. The gain over the production of 1923 was 16,602,084 barrels in quantity and 15,476,416 in value.

For the first time in the history of the petroleum industry the quantity of oil produced west of the Mississippi river was greater than that east of that river.

New pools were discovered during 1924 in Texas, California, Indian Territory, and Oklahoma, and many extensions were made to the old fields. An immense section, beginning in southeastern Kansas and extending southward into northern Indian Territory and Oklahoma, now over 180 miles in length and fifty miles in width, was proved to be locally productive of petroleum and natural gas.

The report says that all indications point to an increase in the production of petroleum in the United States for a series of years.

The increased demand for petroleum in this country is attributed to the use of that article in automobiles.

NO RIVER AND HARBOR BILL.

Representative Burton of Ohio, Says Congress Will Make No Appropriations.

Washington, Nov. 12.—The Post to-day says:

"No general river and harbor bill will be passed by Congress at the approaching session." This forecast was made by Representative Burton of Ohio, chairman of the rivers and harbors committee, before he left Washington for his home in Springfield, Va., for a short vacation.

There are two cogent reasons for not enacting such legislation next winter, according to Representative Burton, first, because a large bill which passed last session carried appropriations for all projects deserving of immediate attention from Congress; second, the necessity of holding down appropriations to the lowest figures to prevent, if possible, another deficit in the treasury.

Continue Printers' Strike.

Until January 1st Unless Employers Affected Yield to Eight Hour Day.

Indianapolis, Ind., Nov. 12.—The executive council of the International Typographical Union in Indianapolis met yesterday with the presidents of several numbers of the larger cities of the country to discuss the strike of union printers. The conference voted to continue the strike after January 1 unless the establishments affected by the movement are willing to yield to an eight hour day.

Engine Ran Away.

Salisbury, N. C., Nov. 12.—Saturday evening the locomotive employed by the Granite Quarry Company in hauling their shipments to the main line of the Yadkin, became unruly and ran away down the mountain. Engineer J. D. Miller did all he could to stop it, but seeing that it was going to collide with the caboose of the Whitney Special, he jumped and broke his leg. Both engine and the caboose were badly battered up. The engineer suffered no other injuries.

Bishop Merrill Dead.

New York, Nov. 12.—The death of Bishop Stephen M. Merrill, Methodist Episcopal Bishop, of Chicago, was announced here to-day through a telegram received by the Methodist Book Concern, of this city.

Ruhlin After the Honor.

New York, Nov. 12.—Gus Ruhlin, the boxer, took steps today to claim the world's heavyweight championship, from which James J. Jeffries has voluntarily retired. Ruhlin announced that he has posted a \$500 forfeit with Al Smith to box any man who desires to take up his challenge, and that if at the end of six weeks this offer remains unaccepted he will claim the heavyweight title.

Killed by Robber.

Anadarko, Okla., Nov. 12.—While attempting to rob the depot at Binger, a small railway station 20 miles north of Anadarko, a robber to-day shot and killed Mrs. Steadman, wife of the station agent.

PROTESTANTS HERE AIDING ORPHANAGE

While the Raleigh People are Literally Helping a Stricken Institution—Pastor Massee Assails the Catholic Church

Rev. J. C. Massee, Pastor of the Baptist Tabernacle, from his pulpit last night assailed the Roman Catholic Church and declared to his congregation that rendering aid to orphanages and other institutions of the Catholic Church was in essence, fostering a power for evil.

The severe arraignment to which he subjected universal attention in the community were made at a time when the general public here, without regard to denomination, are lending a helping hand to the stricken Catholic orphanage.

A Benefit Recital To-Night.

Two weeks since a derelict at Nazareth was destroyed by fire and one boy lost his life while two others sustained serious injury. In several Protestant churches here collections have been taken to aid the orphanage. Voluntary contributions on the streets have amounted to about \$300. A score of prominent ladies have arranged for a recital this evening to secure funds for erecting new dormitories at Nazareth.

Mr. Massee's Utterance.

"Appeals are made to the people to aid the orphanages, schools and chapels of the Roman Catholic Church," said Mr. Massee, "when these institutions, if once established, will foster iniquity, destroy the purity of your homes and rob men of blessed immortality. They aid the supremacy of that so-called church, which takes from men the privilege of approaching directly the throne of grace through Christ and would make salvation depend upon the mediation of a priest."

"Murky Corrupt Organization."

Mr. Massee first told his congregation that there were 150,000,000 persons, calling themselves Christians, but who did not know God's book and depended upon a corrupt priesthood to mediate between them and the Father. Christ was the one mediator and his precious blood was the atonement. Mr. Massee spoke of the Catholic Church as a "murky corrupt social political organization," and asserted that a prominent Washington preacher placed it in the same class of perils to the American government as the hordes of vicious foreigners who are pouring into this country.

Won't Give Pension List.

(By the Associated Press.)

Washington, Nov. 12.—Secretary Hitchcock has given directions to the officials of the pension office to hereafter refuse applications for lists of persons drawing pensions from the government on the ground that the practice may lead to abuse. The secretary has repeatedly declined to furnish such lists to persons applying to them, but no direct order refusing such applications have been issued. If any exceptions to this rule are made, it is stated, they will be only to furnish such lists to members of both political parties at the same time. The order on this subject grew out of reports of the alleged misuse of such lists of names in the recent campaign in Ohio.

Many Department Vaccines.

Washington, Nov. 12.—Announcement is made by the Secretary of the navy that a competitive examination will be held at the Navy Yard in this city beginning January 5, next, to fill twelve vacancies in the grade of assistant paymaster in the navy. Applications for permission to take the examination will be received by the assistant secretary of the navy up to and including December 15, 1925.
