

(By Leased Wire to The Times.) Russell, chief of the strategy board of the striking telegraphers, is preday to appear before Attorney General Jackson and ask that action be instituted in the courts to annul the charters of both the Western Union

and Postal companies. He will present a mass of evidence that the companies have been forwarding messages by mail and express after collecting full telegraph tolls. He will further charge that messages have been shipped into New York, copied on the proper blanks at the main offices and delivered as if they had actually come over the wires.

Attorney General Jackson has been anxious to get at the telegraph trust ever since they entered into a working agreement for the division of profits and raising of rates. The aupreme court recently refused him permission to bring suit against the companies on the ground that they had conspired to form a monopoly.
