The capital fund for common schools is \$1,153,000; & 420,000 have been taught in them dur ing the last year. The Canal debt is 87,787,770 S9; and the annual interest 419,023 65. Attention is recommended to agriculture, and to mechanic and scientific institutions. A revision of the criminal code is recommended. An extension of the Penitentiary system is recommended. Among other subjects to which Legislative attention is called, are, the state of the militia; the establishment of the validity of titles; the election of an United States Senator : a mode of compelling the attendance of witnesses; the erecting of a monument to the late Commodore McDonough.
