"More legs are lost in this war than arms, but we don't know why," says Major Boehm, of the Canadian army.

Amuptations of any kind are much less numerous than we imagine. With some 400,000 soldiers abroad, and that, too, in the very toughest fighting that an army has had to face, there have been fewer than 1.050 amputations among Canadian soldiers.
