He returned two weeks ago, and Thursday night he and Mrs. Lomax, in the latter's automobile, left the city together after midnight on a "joy ride," and Friday morning the wrecked automobile was found on the road near the park. Yesterday Mrs. Lomax was entered as a patient in the hospital At this hour Prince is still living but unconscious, and there is no lope for his recovery. The murder and attempt at suicide was a shock to the whole city as both were from prominent families.


