EAMOUS ROGUE DEAD.

Jimmy Logue Eads His Days In the Almshouse In Philadelphis.

A Philadelphia dispatch says: Worn out by years of confinement resulting from his long career in crime, "Jimmy" Logue, the famous ex-convict who is believed to have stolen more money than any other thief of his time, and who was, perhaps, the bestknown bank robber of the age, died in county almshouse Wednesday at the age of sixty-two years.

He sought religious consolation before he died. Logue is supposed to have had a fortune at one time of about \$300,000.

of the first rating, carrying twenty main battery guns and having a total displacement of 9,215 tons, and is so well thought of by Rear Admiral Schley that he desired that she be assigned as his flagship in the new south Atlantic squadron.

The Marietta is a composite gunboat of 1,000 tons displacement and with a main battery equipment of six guns.

The Machias, with a displacement of 1,177 tons, carries a battery of eight guns. Their commanders are all veterans of long experience in the service. The Brooklyn is commanded by Captain Theodore F. Jewell, who has seen fourteen years of sea service and much more than that on shore stations; the Machias by Lieutenant Commander Leavitt C. Logan, with fifteen years of sea service, and the Marietta by Lieutenant Commander Edward H. Gheen, whose record shows seventeen years of sea service.

The Brooklyn's formidable equipment will make her of invaluable general service, while the Marietta and the Machias are expected to be of much usefulness in the anmerous shallow waters about the archipelago where larger craft cannot go.

It is not known how soon these vessels can be ready, but their orders are to get away as early as possible, and no delay is anticipated. Their commanders will report to the department when they are ready to proceed and on arriving at Manila will report without delay to the admiral commanding the Asiatic station, for orders.

in the Celebrated Carter Case Made Publi At Washington.

The opinion of Attorney General Griggs in the case of Captain Oberlin M. Carter, of the army, upon which the president approves the finding of the courtmartial, was made public at Washington Thursday.

After dismissing certain of the minor charges as unproven, the attorney general took up the more serious questions involved, first considering the objection that the charges upon which Captain Carter was found guilty were incongruous. He says that, unlike the ordinary criminal procedure, the military usages and procedure permit of an indefinite number of offenses in one and the same proceeding.

"It is not necessary," he says, "to discuss whether this practice is wise, or whether it is prejudicial in the rights of the accused. It appears to be established by long continued practice, and, so far as I am able on investigation to discover, without previous challenge.'

But even if this objection were well founded, the attorney general says, he does not think the accused should be allowed to avail himself of the objection now, because he proceeded to trial without objection to this alleged misjoinder, and permitted the court to enter on the investigation of all of the different specifications, and himself brought forward his defense as to each of them. The objection should have been promptly taken to be made available.
