#### A FLAG POLE

The flag donated would have lasted for years with proper care, but with conditions as they are every flag placed on the Court House will go to pieces in a short while.

It seems to us that a flag pole could be very approprately erected on

the right of the Court Square. This would permit the raising of the flag each morning and its lowering each afternoon; it would also be more easily seen from all sections of the town. This flag pole mounted in a cement base, would cost little, and its value at this time cannot be measured in terms of cost of erection.
