NEW YORK, Jan. 19.-An alarming increase in the number of deaths from carbon monoxide asphyxiation during recent months has been noted by the statistical bureau of the Fidelity and Casualty Co., of New York, according to W. McK. Hillas, vice-president in

No complete figures are available to show exactly the extent of the increase, Mr. Hillas said, but the percentage gain for 1930, as compared with the fatalities that occurred from this cause in 1928 and 1929, was very large.

Particularly noticeable, he added have been the many deaths from such poisoning taking place in one and two-car private garages due to the operation of automobile engines with doors and windows of the buildings tightly closed.
