

#### **HEAVY VOTE IS** All Constitutional **Amendments** Are **Carried By Voters**

Raleigh, Nov. 5 .- Mounting returns from the General election increased the overwhelming Democratic majority in North Carolina and gave substantial majorities for the five constitutional amendments. Returns from 1312 of the State's 1855 precincts gave President Roosevelt a better than 3-to-1 majority in the Presidential race. The vote was: Roosevelt, 465,541; Landon,

With 1082 precincts reported in the gubernatorial election, Clyde Hoey, the Democratic nominee, was leading Gilliam Grissom, the Republican candidate, 332,235 to 141,-878. All Democratic candidates for State office won by an overwhelming majority.
