

Norlina Boy Elected State FFA Officer

Ronnie King, a 1965 graduate of Norlina High School, was elected a state vice-president at the annual statewide convention of the Future Farmers of America held in Raleigh last week.

The son of Mr. and Mrs. Gerston King of Warrenton, Rt. 1, Ronnie was president of the Norlina FFA Chapter during 1964-65.

Clint Hege, vocational agriculture teacher at the Norlina school and chapter advisor, said yesterday that Ronnie had made an outstanding record in FFA and vocational agriculture since entering high school four years ago. In addition to an excellent supervised farm program, which has increased each year, Ronnie has participated in many FFA contests. He won the public speaking contest and was a member of the parliamentary procedure team. He attended the State FFA Leadership School in 1964 and also attended the national convention the same year.

At the 37th annual convention held at Reynolds' coliseum at State University last week, Hege said, 20 of the state's most outstanding boys were selected as possible nominees. This number was reduced to ten and then to six by the nominating committee. After interviewing these six boys one or more times during a two-day period, the committee presented the six to the assembled delegates and were duly elected.

As a state officer, Ronnie will be expected to speak at local chapter banquets, and speak to business groups and clubs concerning the work of the FFA, represent North Carolina at the National Convention in Kansas City, Mo., in October, and help in developing leadership on a statewide basis.

Ronnie will enroll at N. C. State University in September in the College of Agriculture. He is the second boy from the Norlina FFA Chapter to be elected to a state office. Allen Kimball, Jr., has previously been a state officer.
