

Decided At Adjourned Session

Warren County will again participate in the North Carolina Commodity Distribution Program, commencing on January 2 and continuing into April. Last year the program under which free food was distributed to needy families of the county was started in February and continued until April 15. A decision to again participate in the program was made Tuesday night in an adjourned meeting of the board of county commissioners.

All commodities will be furnished by the county for distribution by the State and Federal governments. In addition the state and federal agencies will subside the cost of a warehouse to store the commodities, from where they will be distributed, and to pay the salary of a manager.

The county has been unable to have the distribution made under the Stamp Plan. Commissioners said Tuesday night that it is imperative that some assistance be given to needy families of the county during the winter months.

Those who will receive the commodities must first be certified by the Warren County Department of Welfare. The commissioners agreed to employ extra help for the Welfare Department and named Tommy Miles as a case worker, and Mrs. John Ellis and Mrs. Inez sist with the verification which will be under the supervision of Welfare Director Julian Far-

Registration for certification will be started on Monday morning, Nov. 22, in the Grand Jury


